She was the only female in the class and also gained her heavy vehicle licence, forklift licence and is working towards an air-conditioning course with a long-term plan to also complete an auto-electrical course.
3. We have applied for a grant from Women NSW to expand our 'Girls in Trades' campaign and run a program in schools to showcase all the career opportunities available to women in non-traditional trades. We are currently waiting to hear if we have been successful.
